 - 1) PROMINENTLY DISPLAY DUNCAN RACING STICKERS ON BOTH FRONT AND REAR FENDERS OR IN HIGHLY VISABLE LOCATION(S) OF THE RACING MACHINE, SUCH AS RADIATOR SHROUDS, HANDGUARDS, ETC.
 - 2) PROVIDE DUNCAN RACING WITH **TIMELY RACE RESULTS**. (Results can be emailed to sales@duncanracing.com)
 - 3) GRANT DUNCAN RACING THE RIGHT TO USE THE RIDER'S NAME, LIKENESS, RACE RESULTS, PHOTOS (**DIGITAL PHOTOS ON CD PREFERRED, ACTION PHOTOS WHEN POSSIBLE**) AND **WRITE-UPS IN ANY ADVERTISING AND/OR PROMOTION OF DUNCAN RACING PRODUCTS AND/OR RELATED SPONSOR PRODUCTS**.
